Message from the President

President's Report to the 2010 Annual General Meeting of the Olive Tree Foundation



It is my great honour and pleasure to deliver this message on behalf of the Olive Tree Foundation. As President of the Foundation, I could not be more pleased with the achievements of the organization during 2010.

While the Olive Tree Foundation is an emerging, volunteer-run public foundation, it continues to make an impact in the community.

As a result of the funds raised during our Annual Ramadan Campaign, we were able to provide grants to fund a number of worthwhile projects in 2010.

The Foundation awarded a grant to the Tessellate Institute for the project, "Canadian Muslim Youth: Concepts of Political Participation" which was done in conjunction with the Muslim Educational Network, Training and Outreach Service. The project provided policy-makers and community leaders with much-needed empirical data that will assist in policies aimed at encouraging Canadian Muslim youths' political engagement within Canada.

A grant was also awarded to MIST (Muslim Interscholastic Tournament) and ISNA Canada for the annual competition of high school students. MIST is an educational, interactive program of competitions and workshops geared towards bringing students together to develop leadership, communication and creative skills, all while gaining a deeper understanding of their faith and values.

The Olive Tree Foundation was also pleased to support the inauguration of the Ontario Association of Islamic Schools (OAIS) with a grant to the Muslim Educational Network, Training and Outreach Service. OAIS is an umbrella organization that will bring together Islamic schools across the province to increase their efficiency by reducing costs of educational services; provide professional and leadership development training of teachers; and help Islamic schools in developing a standardized curriculum.

The Foundation was once again at the forefront of supporting disability rights with the awarding of a grant to the Centre for Independent Living Toronto and the Canadian Association of Muslims with Disabilities (CAMD) for the project "Spring into Disability Rights Campaign 2010". Support was also provided to the MOEEN Centre for their annual gala event. The MOEEN Centre is a charitable organization that provides services for physically disabled and developmentally challenged, young adults.

As a philanthropic organization that promotes community development we continue to build the Foundation to occupy a clear, distinctive, and desirable place in the minds of donors, volunteers, and partners.

I want to express my sincere thanks for the time and support provided by the Board of Directors who have given freely of their time in support of the Foundation.

I would like to thank all of our members, volunteers and generous donors who have supported the Olive Tree Foundation over the past year. I also thank the recipient organizations for working along with us in our granting process.

We look forward to the coming year with anticipation and enthusiasm. And we invite our community to join us in building a brighter future, today.

Mission, Vision and Values

Mission

The Olive Tree Foundation is dedicated to promoting and perpetuating philanthropy and enhancing community life through responsible grant making in Canada.

The Olive Tree Foundation encourages and facilitates the creation and growth of endowment funds to enable the community to realize its potential. The Foundation maintains effective stewardship over all assets entrusted to it; distributes grants that reflect donors' wishes and community priorities; and provides leadership in the Muslim and general communities.

Values and Purpose

The Olive Tree Foundation was founded in 2004 by civic leaders and philanthropists within the Canadian Muslim community.

The Foundation is a charitable organization formed to attract and manage permanent endowment funds and to distribute income from those funds back to the community. We provide grants to registered charitable organizations for projects that maintain or improve quality of life in the community.

Unlike other charities, which are usually dedicated to a single cause, the Olive Tree Foundation supports a range of charitable activities in our community: social, community and health services; education and library services; policy institutes and think tanks; and arts, culture & heritage. Because of this unique mandate, we can provide seed funding for new projects or other initiatives that might otherwise fall between the cracks.

Our Foundation also has a mandate to act as a catalyst for community initiatives that support and sustain our community. An endowment foundation (*Waqf*) is an institution that has been part of the Islamic historical experience and has, in the past, provided for the flourishing of the Muslim contribution to societies. The establishment of such an institution in Canada will provide a vehicle for leaving an ongoing legacy and contribution to the Muslim community and to Canada.

The guiding principles of the Olive Tree Foundation are to provide support where there is genuine need, build on the strengths of the community and encourage innovation and community development.

Year in Review

Study on Muslim youth involvement

The Olive Tree Foundation has announced that it will fund a study by the Tessellate Institute (TTI) on "Canadian Muslim Youth: Concepts of Political Participation."

TTI's project will be conducted in the context of growing governmental and community concern over the 'radicalization' of Canadian Muslim youth.

By investigating, through empirical research, their perspectives on participation, the research aims to learn what Canadian Muslim youth think about politics and their involvement with it.

The study will seek to answer some pressing questions: Are they similar to other youth, who are only marginally involved in formal political processes? Do they share with other Canadian youth a more extensive involvement in local, voluntary, and civic engagement? What is their political socialization in the home, at school, in civic associations, amongst peers? Is there a sub-culture(s) particular to Canadian Muslim youth as far as political engagement goes? What demands are Muslim youth placing on the political system? What diffuse support do they offer to the Canadian regime? Are Canadian Muslim youth being 'radicalized?'

Public foundation recognizes 'good works'

The Olive Tree Foundation celebrated community development at its Annual Appreciation Brunch on Sunday June 20, 2010.

"Successful public foundations that fund community initiatives can lead to community development," said Muneeb Nasir, President of the Olive Tree Foundation.

The event, titled, 'Leading Community Development', recognized the Foundation's contributions as one of Canada's first Muslim granting agencies and public endowments, and recognized the Olive Tree Foundation's donors and grant recipients.

The event was attended by a number of nonprofit organizations, community workers and supporters of community development.

"Our annual event recognizes all those who are doing good works and providing services to our community," Nasir told the audience in his opening remarks.

Ontario Association of Islamic Schools

TORONTO, ON, January 28, 2011 – Olive Tree Foundation has announced that a grant of \$4,000 has been awarded to the Muslim Educational Network, Training & OutReach Services (MENTORS) for the "Ontario Association of Islamic Schools Action Planning Project".

The Ontario Association of Islamic Schools Action Planning Project is an initiative to form an umbrella organization that looks after the collective needs of Islamic schools in the province.

"The Olive Tree Foundation is very pleased to fund this initiative that will bring together Islamic Schools in Ontario," said Muneeb Nasir, President of the Foundation, in announcing the grant. "Anytime we come together for the betterment of our children, their families and this society, we are making an important civic contribution."

Ontario has over 50 Islamic schools that run privately and each school must register with the Ministry of Education in order to operate in Ontario. Unlike other Faith groups, Islamic schools do not have a school board.

Alimamy Bangura, Executive Director of MENTORS, outlined a number of benefits to be gained by creating an association of Islamic schools, such as providing professional services — social workers, psychologists, curriculum specialists, speech and language pathologists and special education experts to Islamic schools.

"One of the greatest pluses of such a body would be reducing costs related to education services such as purchasing equipment and supplies, text books, library resources, etc., in bulk to benefit from the economies of scale," Bangura said.

He said that sharing best practices and advocating to government and other agencies on behalf of all Muslim schools on issues such as the tax system, funding and legal issues will be of vital importance.

CAM-D celebrates big and honours champions at Annual Gala

(March 14, 2011) – North American Muslims have fallen short in addressing disability issues in their communities according to Imam Zaid Shakir.

Imam Shakir made the remarks during his keynote address at the Canadian Association of Muslims with Disabilities (CAM-D) 'Building Opportunities for People with Disabilities 2011 Gala Dinner' that took place on Sunday, March 13.

He called on the audience to be actively engaged in helping those members who are on the margins of the community.

"If we are not assisting them, can we expect Allah to assist us?" Imam Shakir said. "Religion is not talk."

Imam Zaid Shakir is a prominent American Islamic Scholar, writer and co-founder and faculty member of Zaytuna College in Berkeley, California.

"We sometimes look for the causes of our problems outside of ourselves," he added. "But the first place to look is in the mirror, at ourselves."

The dinner event, which drew 400 people, took place at the Candles Banquet Center in Mississauga and was chaired by Rabi Khedr, the Executive Director of CAM-D and the visionary behind the organization.

CAM-D is a non-profit association of Muslims with disabilities whose vision is to create a global village that includes full access for persons with disabilities.

The organization also distributed its first annual CAM-D awards during the program in recognition of individuals and organizations that are at the forefront of raising the quality of life for people with disabilities in the Canadian Muslim community.

The Olive Tree Foundation was recognized for its ongoing commitment to advancing disability rights and awarded the CAM-D Towards An Inclusive Society Award 2011.

"CAM-D must be commended for its excellent work in raising the awareness of disability issues in the Muslim community," Muneeb Nasir, President of the Olive Tree Foundation commented. "We are indebted to them and, most especially, to Rabia Khedr for the leadership she has provided in this area."

The Lieutenant Governor of Ontario, David C. Onley, sent greetings to everyone attending the Gala.

"As the 28th Lieutenant Governor of Ontario, and the first with a physical disability, I have taken on "Accessibility" as the over-arching theme of my mandate," David Onley wrote. "Accessibility to me means that which allows people to achieve their full potential – those with not only physical disabilities, but also nonvisible ones."

The Lieutenant Governor also sent his congratulations to the award recipients of the CAM-D awards.

"As The Queen's representative in Ontario, I congratulate this evening's honourees: the Olive Tree Foundation; the Islamic Foundation of Toronto; the Muslim Association of Canada – Masjid Toronto; and Shaikh Abdool Hamid," he wrote.

CAM-D offers a number of programs including special projects with mosques such as Access Islam 101 in ASL (American Sign Language), residential planning for individuals with severe disabilities when caregivers pass away, activity nights for youth and adults with intellectual/developmental disabilities, as well as, ongoing public education.

Annual scholarship and bursary awards

(March 25, 2011) - The Olive Tree Foundation and MENTORS (Muslim Educational Network, Training and Outreach Service) have announced that they will provide an annual scholarship and bursary awards to students entering full-time programs of study at a college or university in the upcoming academic year.

The Muslim Scholarship and Bursary Awards are funded through the endowment funds of the Olive Tree Foundation.

The awards will be handed out at the Annual Olive Tree Foundation's Gala Dinner on Saturday, June 25, 2011.

An annual scholarship of \$1,000 is made possible through the endowment of Mohamed and Opheera Nasir family fund.

The Mohamed and Opheera Nasir Leadership Scholarship, has been established to honour the significant contributions to the Canadian Muslim community of late Mohamed Nasir and his wife, Opheera Nasir; and as a memorial to honour their parents Shabaan and Mohammed Nasir (parents of Opheera) and Jinette and Mohamed Ishmael (parents of Mohamed).

The recipients of the scholarship will be chosen on the basis of exceptional leadership qualities and social conscience, as well as, academic achievement.

4 bursary awards of \$500 each will also be awarded. These awards are made possible through the returns from the Olive Tree Foundation's Community fund.

The **Academic Excellence** bursary will be awarded to a high school graduate who has excelled in academic studies.

The **Women Educational** bursary will be awarded to a graduating female student who excelled in school despite the exceptional challenges and barriers she faced as a Muslim woman.

The **Youth Action** bursary will be awarded to a student who has taken consistent action to make a positive impact on the larger community.

The **Special Needs Student** bursary will be awarded to a high school student with disability who excelled despite the exceptional challenges and barriers she or he has faced.
